agree to follow all established rules & regulations. I/We understand that violations of these rules may result in revoking our membership to the pool without refund of dues paid. I/We understand that this membership entitles our immediate family the rights & privileges of pool use during operational hours. I/We further understand that this membership is made on a year-to-year basis and does not afford me the right to vote as a member of SGCC. I/We are aware that all concerns must be addressed in the following order to the Pool Manager, Club Manager finally the Pool Representative of SGCC's Board of Directors.

Pool Rules and Regulations

1. **NO Lifeguard is on duty at the pool.** Pool Participants must exercise safety in swimming at all times. All persons using the pool do so at their own risk. South Granville Country Club and management are not responsible for accidents and injuries.
2. **Children under 14 years old must be accompanied by an adult or childcare provider at all times. Childcare provider must be at least 16 years old.**
3. Pool Participants are responsible for the supervision and actions of their children. Members are responsible in assuring that all their guests adhere to all posted pool rules.
4. **No running, boisterous or rough play.** No diving allowed in areas of pool less than 5 feet deep or in pool areas not approved for diving. No jumping in too close to the edge of pool.
5. **No Glass Containers allowed!** Participants are responsible for all trash brought into the pool area.
6. **Persons under the influence of alcohol or drugs are not allowed use of the pool.** Disorderly conduct will not be tolerated by pool participants and they will be asked to leave the pool area.
7. **Tobacco products are allowed in designated areas.** Please respect other pool participants and dispose of tobacco debris properly.
8. Animals and pets are not allowed in the pool area or on the pool deck.
9. Only pool balls and floats are allowed in the pool. **No baseballs, softballs, footballs, volleyballs, soccer balls, basketballs allowed.** If in doubt, ask pool attendant. Please be considerate of others in the pool when using pool toys. The pool attendant may ask that certain pool toys be removed from the pool area if they are disruptive to others or the pool is crowded. Any small objects that are used to be thrown will be taken away by pool attendant.
10. **Persons with skin, eye, ear, or nasal infections are NOT allowed in the pool. No person with a communicable disease or diarrhea is allowed in the pool.**
11. Parents/childcare providers are responsible for discipline of their children. If an individual causes safety or discipline concerns, the pool attendant shall first warn the individual of the infraction, secondly notify the parent or childcare provider and then has the right to remove the individual from the pool. This may include the sitting on the side of the pool for periods up to 30 minutes. If infractions continue, the individuals will be asked to leave the pool for the day.
12. The pool attendant has total control of the pool operations. In adherence with the **Thunder/Lighting Policy**, if you hear thunder you must leave the pool and if lighting is visible the pool is closed without hesitation and exception.
