## SGCC Pool Membership Supplemental Agreement

This membership application is deemed to be a contract between you and the South Granville Country Club, Inc. By executing this contract, you agree to be bound by the annual membership rates that apply, and any charges that may be incurred by you, your family, or your guests. I/We understand that this membership is made on a year-to-year basis and does not afford me or my family members the voting rights of a full member of SGCC. Additionally, by executing this contract you agree that you are entering and using the pool facility at your own risk and that you are responsible to explain that to all members of your family and guests. As a Pool Member of South Granville Country Club Inc., I/We agree to follow all rules & regulations listed below. I/We understand that violations of these rules and regulations may result in suspension or revoking my/our membership to the pool without any refund of dues paid. I/We understand that this membership entitles my/our immediate family the privileges of pool use during operational hours. I/We agree that all questions, complaints, or concerns should be reported to the pool attendant on duty. Any question, complaint, or concern which the attendant cannot answer should be emailed to the SGCC Board of Directors at [Pool@sgcconline.com](mailto:Pool@sgcconline.com) or [Proshop@sgcconline.com](mailto:Proshop@sgcconline.com). It is not the attendant's responsibility to forward your question, complaint, or concern.

### Pool Rules and Regulations

1. **NO Lifeguard is on duty at the pool.** All person's swimming in the pool do so at their own risk. The pool attendant on duty has the authority to enforce all rules and regulations. Pool participants must always exercise safety in swimming. South Granville Country Club and its management are not responsible for accidents and injuries.
2. The pool attendant has total control of the pool operations. In the event of approaching thunderstorms, the attendant will provide directions. If lightning is visible, the pool will be closed without hesitation or exception and all participants are required to leave the pool area immediately. The attendant will determine when it is safe to re-enter the pool area.
3. **We are a family-oriented pool. Proper swim attire must be worn at all times while attending the pool. All men's/boys swim wear must have a liner. Underwear or other under garments are not allowed to be worn under the swimsuit. Brazilian/ French cut thongs, micro string bikinis, or swimwear which exposes more than 1/3 of the buttock cheek, is prohibited. Any bathing suit which is translucent or becomes translucent when wet is prohibited. For bathing suits designed to be worn as 2-piece, the top must cover 50% of the breast. The attendant on duty may remove any offender who does not comply.**
4. **Children under 14 years old must be accompanied by a parent, or childcare provider at all times. The childcare provider must be listed on the application and check-in roster. No substitutions without prior permission.**

5. Parents/childcare providers are responsible for the actions of their children. If a child violates any rule or causes safety concerns, the pool attendant shall first warn the individual of the infraction or concern, secondly notify the parent or childcare provider. Continued violations or actions may result in the attendant removing the individual from the pool. The attendant may impose disciplinary action which may include having the individual sit out of the pool for periods up to 30 minutes. If violations continue, the individual will be asked to leave the pool facility for the day.
6. Members are responsible for ensuring all of their guests adhere to all pool rules and guest conduct guidelines.
7. **No running, boisterous or rough play.** No diving allowed from pool areas marked as no diving. No jumping into the pool next to the edge or side of the pool. No jumping on or at another swimmer.
8. **Profanity is prohibited. Warnings will be issued once. Repeat offenders will be asked to leave the pool area for 24 hours.**
9. **Glass or Breakable Containers are prohibited!** Participants are responsible for cleaning and properly disposing of all litter and containers purchased at or brought to the pool area.
10. **Persons under the influence of alcohol or drugs are NOT allowed to use the pool.** Disorderly conduct will not be tolerated. Individuals exhibiting such behavior will be asked to leave the pool area immediately.
11. **Use of tobacco products are prohibited inside the fenced area. This includes vaping and E-cigarettes.**
12. Animals and pets are prohibited in the pool area or on the pool deck.
13. Balls, toys, and floats designated for pool use are allowed in the pool. **Golf balls, Baseballs, softballs, footballs, volleyballs, soccer balls and basketballs are prohibited.** If in doubt, ask the pool attendant. Please be considerate of others in the pool when using pool toys. The pool attendant may ask that certain pool toys be removed from the pool area if they are disruptive to others or the pool is crowded. Any small objects that are thrown may be taken away by pool attendant.
14. SGCC is not responsible for loss or damage of personal property.
15. **Persons with infections of the skin, eye, ear, or nasal passages are NOT allowed in the pool. No person with or suspected of having an infectious or communicable disease or diarrhea is allowed in the pool. Spitting, spouting water from the mouth or blowing of the nose in the pool is prohibited and may lead to suspension or termination of membership.**
16. **Non-potty-trained children must wear swim-proof diapers or rubber swim pants. All diaper changes must be performed in the restroom regardless of the child's age.**
17. **Anyone who causes contamination to the pool (fecal or vomit contamination) whether willfully or not, will be fined \$100 for the first offense, \$200 fine and a 30-day suspension for subsequent offenses. We are required by the health department to close the pool for 24 hours after treating the pool for contamination.**
18. The member agrees to abide by all Federal, State and County or Club restrictions, guidelines and policies which affect the operation of a pool.

**19. No member or guest will enter the area marked Employees Only or go behind the attendant's counter for any reason. Violations may result in expulsion from the pool area and or termination of your membership.**
