## Pool Membership Supplemental Agreement

**As a Pool Member of South Granville Country Club Inc., I/We** agree to follow all rules & regulations listed below. I/We understand that violations of these rules and regulations may result in suspension or revoking my/our membership to the pool without any refund of dues paid. I/We understand that this membership entitles my/our immediate family the privileges of pool use during operational hours. I/We further understand that this membership is made on a year-to-year basis and does not afford me the right to vote as a member of SGCC. I/We are aware that all concerns must be addressed in the following order, the pool attendant on duty, Pool Manager, Club Manager, SGCC's Board of Directors.

### Pool Rules and Regulations

1. **NO Lifeguard is on duty at the pool.** The pool attendant on duty has the authority to enforce all rules and regulations. Pool Participants must exercise safety in swimming at all times. All persons swimming in the pool do so at their own risk. South Granville Country Club and management are not responsible for accidents and injuries.
2. **Children under 14 years old must be accompanied by a parent, adult or childcare provider at all times. The childcare provider must be at least 16 years old.**
3. Parents/childcare providers are responsible for the actions of their children. If an individual causes a safety or discipline concerns, the pool attendant shall first warn the individual of the infraction, secondly notify the parent or childcare provider and then has the right to remove the individual from the pool. The attendant may impose disciplinary action which may include having the individual sit out of the pool for periods up to 30 minutes. If infractions continue, the individual will be asked to leave the pool for the day.
4. **No running, boisterous or rough play.** No diving allowed in areas of pool less than 5 feet deep or in pool areas not approved for diving. No jumping into the pool next to the edge or side of the pool. No jumping on or at another swimmer.
5. Members are responsible for assuring that all their guests adhere to all posted pool rules and guest conduct.
6. **Glass or Breakable Containers are prohibited!** Participants are responsible for cleaning and properly disposing of all litter and containers purchased at or brought to the pool area.
7. **Persons under the influence of alcohol or drugs are NOT allowed to use the pool.** Disorderly conduct will not be tolerated. Individuals exhibiting such behavior will be asked to leave the pool area immediately.
8. **Use of tobacco products are prohibited inside the fenced area. This includes vaping and E-cigarettes.**
9. Animals and pets are prohibited in the pool area or on the pool deck.
10. Balls, toys and floats designated for pool use are allowed in the pool. **Golf balls, Baseballs, softballs, footballs, volleyballs, soccer balls and basketballs are prohibited.** If in doubt, ask the pool attendant. Please be considerate of others in the pool when using pool toys. The pool attendant may ask that certain pool toys be removed from the pool area if they are disruptive to others or the pool is crowded. Any small objects that are thrown may be taken away by pool attendant.
11. SGCC is not responsible for loss of personal property.
12. **Persons with infections of the skin, eye, ear, or nasal passages are NOT allowed in the pool. No person with or suspected of having an infectious or communicable disease or diarrhea is allowed in the pool. Spitting, spouting water from the mouth or blowing of the nose in the pool is prohibited.**
13. **Proper swimming attire must be worn at all times. Toddlers must wear swim-proof diapers. Diapers must be changed in the restroom and disposed of in a proper container.**

14. The pool attendant has total control of the pool operations. In the event of approaching thunderstorms, the attendant will provide directions. If lightning is visible the pool will be closed without hesitation and exception and all participants are required to leave the pool area immediately. The attendant will determine when it is safe to re-enter the pool area.
15. The member agrees to abide by all Federal, State and County or Club restrictions, guidelines and policies which affect the operation of a pool.
